Minimum Leader qualification:	In house assessed or appropriate level of experience
Max group size with Leader:	12

All Instructors should be making dynamic risk assessments on the day taking into account the weather conditions, the group's ability & any other factors that may change.

Any new venues must be dynamically assessed by the instructors programmed to run the session. Each new site will be assessed on its suitability for the safe running of bushcraft taking into consideration the public safety, participant safety, instructor safety and the ability to run an effective session.

Essential equipment

Personal: Suitable clothing for the conditions.

Group: fire gloves, cooking equipment, tools, matches, a way of putting out a fire (EG: bucket of water, extinguisher, etc..)

Instructor, dependant on venue: Phone, first aid kit, group shelter, torch, hot drink, emergency food, whistle, knife, spare emergency clothing for group (cannot supply for full group, must have a some basics, EG: hats, gloves, etc..)
